

Leichtmetall Aluminium Giesserei Hannover GmbH's (LAGH) Delivery Terms for Aluminium Scrap/Pre-Alloys/Additive Metals for Remelting

- 1. LAGH deliveries shall be carried out free of charge, unless otherwise agreed.
- 2. The metal purchase number (PO No. 45xxxxxx) must be visible on the delivery documents. Please state your commodity tariff number later on the invoice.
- 3. Deliveries must be made from Monday to Friday from 07.00 hrs to 13.00 hrs.
- 4. Delivery dates must be coordinated with the foundry.
- 5. The supplier confirms that all applicable waste management regulations shall be complied with.
- 6. The material thickness of unpressed scrap must be at least 2 mm, unless otherwise agreed.
- 7. If the material is to be tipped, it must be packaged or loose, max. 1.0 m long, and loaded in two individual containers (no semi-trailers, walking floors). Both containers will be tipped by the tractor unit.
- 8. If the material is delivered in packages on pallets/cants, in BigBags or other fixed containers, it must be possible to unload it from the side with a forklift truck.
- 9. Scrap with enclosed airspaces is not accepted.
- 10. The aluminium scrap must not be wet, oxidised, varnished, oily, **emulsified** or covered with snow, nor contain stones, iron parts, paper, plastic or wood residues.
- 11. The lithium content (Li) of the scrap must not exceed 0.0005%.
- 12. Chips are only accepted following prior evaluation and agreement.
- 13. Approximately 6 samples from each delivery will be analysed, all of which must meet the specifications. Deviating regulations are possible with the prior consent of LAGH.
- 14. The supplier confirms that the aluminium scrap is free from any radioactive radiation above the level existing in the environment.
- 15. Please note your information reporting obligations in accordance with Articles 31-33 of Regulation (EC) 1907/2006 ("REACh-VO"), if applicable also delivery of the safety data sheet.
- 16. The supplier confirms that the Conflict Commodities Regulation (EU) 2017/821 and the Dodd-Frank Act are complied with.
- 17. No licensing obligations pursuant to the Dual-Use Regulation 2021/821, the AWV or an embargo regulation (in particular the Russia Embargo Regulation (EU) 833/2014 in its current version) exist for the performance of the supply contract.
- 18. We and our suppliers are not included in the applicable sanctions lists (Consolidated list of persons, groups and entities subject to EU financial sanctions CFSP) as amended from time to time.
- 19. LAGH is committed to upholding standards of human rights due diligence, environmental protection, and fair competition in accordance with its Code of Conduct and expects all business partners to do the same.
- 20. The supplier confirms that it grants LAGH, its customers and regulating authorities the right of access to the affected areas of all facilities and to the corresponding documented information at each level of the supply chain for the ordered goods.
- 21. Unless otherwise agreed, LAGH's delivery weight specified on the weighing card is decisive.
- 22. In the case of master alloys and additional metals, unless otherwise agreed, the net delivery weight of the supplier shall be decisive if it deviates by max. +/- 20kg from the LAGH weight chart.
- 23. Maximum permissible total weight incl. truck, chassis and container: 40,000 kg on the entire German road network: Trucks whose delivery is not accepted due to the above-mentioned deviations may only leave the factory premises with a max. total weight of 40t.
- 24. LAGH shall be informed without delay if circumstances should change in such a manner that the above statements no longer apply.
- 25. We hereby declare our consent to LAGH storing data and information for the purposes of export control.
